Current status of **MPNS** PR:

Overdue, rescheduled for **Fall 2023**: PR for the AS in Science.

For reference, history of this PR:

AS in Science: in **Fall 2015**, a PR was submitted for this program and rejected by the CC with a request for revisions; revised version of 2015 PR **was never submitted**; in **2021**, the PR was due again, an **extension** was requested by MPNS, and the new submission deadline was **Spring 2022**; the new PR was submitted in **Spring 2022 and rejected** by CC with request for extensive revisions; PR was resubmitted later that semester in April 2022 and was not approved by CC; **at the 29 April 2022 CC meeting the PR was tabled until August 2022**; **August 2022, PR for the AS in Science was rescheduled for resubmission by Fall 2023**. In Feb 2023, MPNS Chair Dhital assembled an ad hoc committee of MPNS faculty. As of May 2023 they have completed drafts of sections 1,2,3,4,5,6 (7,8,9 pending), so they are on track to submit by the new Fall 2023 deadline.
