Dear Governor Lujan Grisham,

On behalf of the Education programs at the University of New Mexico – Gallup (UNMG), I request your support of \$100,000 as part of the Tribal Education Initiatives in House Bill 2.

The Tribal Education Initiatives will enhance UNMG's ability to provide student services and instruction in the teacher education programs, including:

- Mentoring, tutoring, and recruitment of students and adjunct faculty;
- Student advising;
- Collaboration with UNM-COE Bachelor's program advisors and faculty;
- Administering PRAXIS tests on campus;
- Instruction of lower-division teacher education and early childhood courses

Teacher vacancies in McKinley County and the surrounding area remain high. The UNMG student population is primarily Native American. The Tribal Education Initiatives funding at UNMG will provide course instruction and support services to help recruit, retain and graduate Native American students who will go on to fill the teaching vacancies in primarily Native American K-12 classrooms.

As the Yazzie-Martinez case revealed, we have failed to provide a sufficient system of education to all New Mexico children, including Native Americans. High teacher vacancies in McKinley County contribute to the inequities and insufficiencies in K-12 instruction. Funding the efforts described will help to create an educational environment where students can learn and thrive.

Management Discussion & Analysis

Fiscal Year 2022 -2023 Budget

This Budget was prepared using the following general assumptions:

1) State Appropriations are based on House Bill 2,

- 2) Tuition & fees are based on estimated enrollments,
- 3) Other sources of revenue and transfers to remain constant,
- 4) Local Tax Levy is based on current assessment values,
- 5) I&G expenditures are reduced to balance the budget.

6) Non-I&G expenditures are based on estimated FY22 actuals and are funded with fees, transfers and sales,

- 7) No use or increase in institutional reserves for I&G,
- 8) Restricted Expenditures are funded by Grants and Contracts.

State Appropriations will fluctuate in the legislative process until House Bill 2 becomes law.

Any compensation increases will increase expenses and revenue at minimal net impact.

Five Year Capital Plan requires a 25% match from Institutional Reserves.

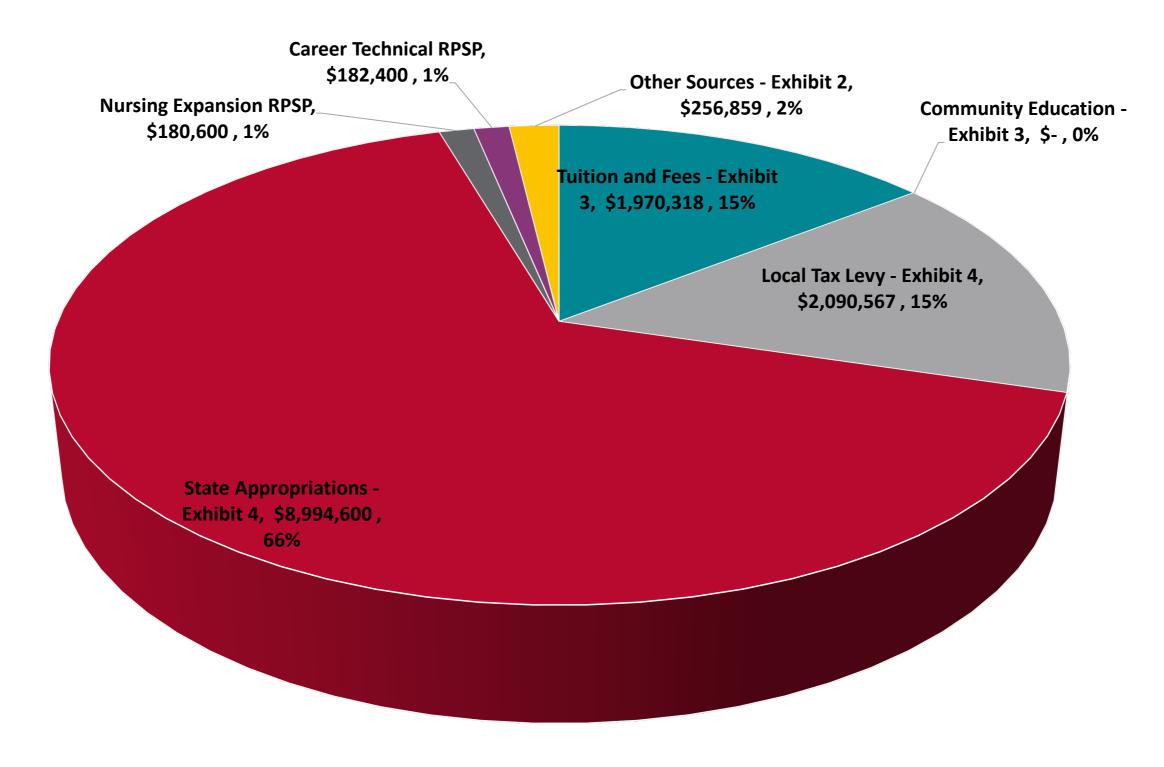

FY2022-2023 Instruction and General Sources of Revenue



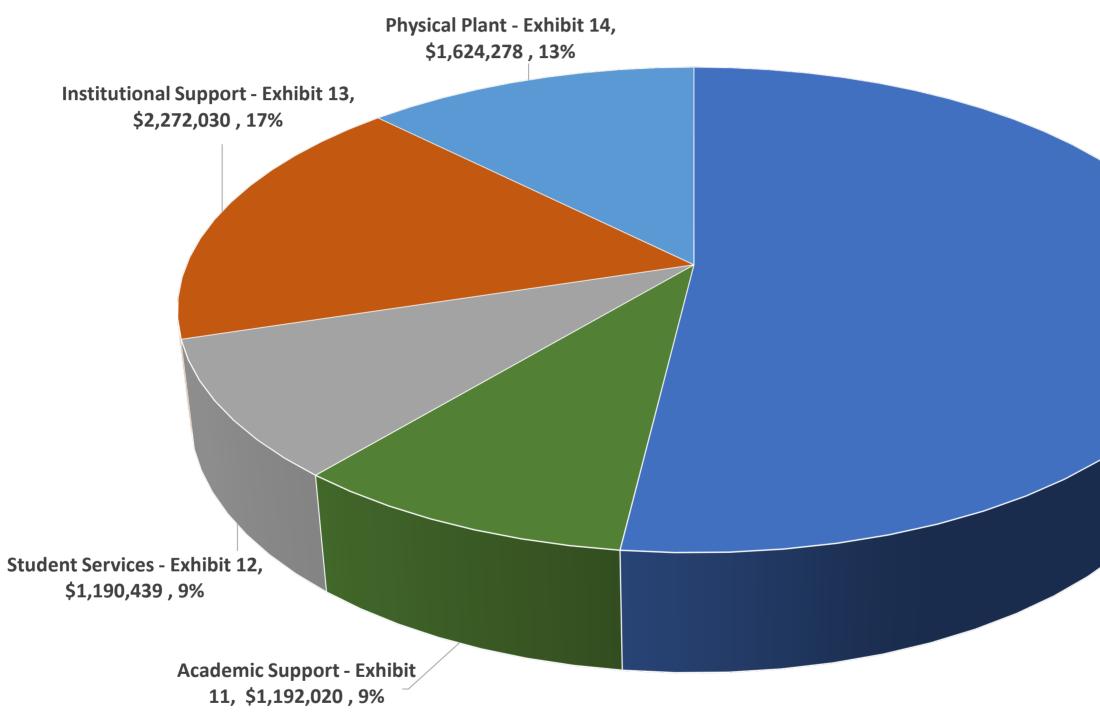

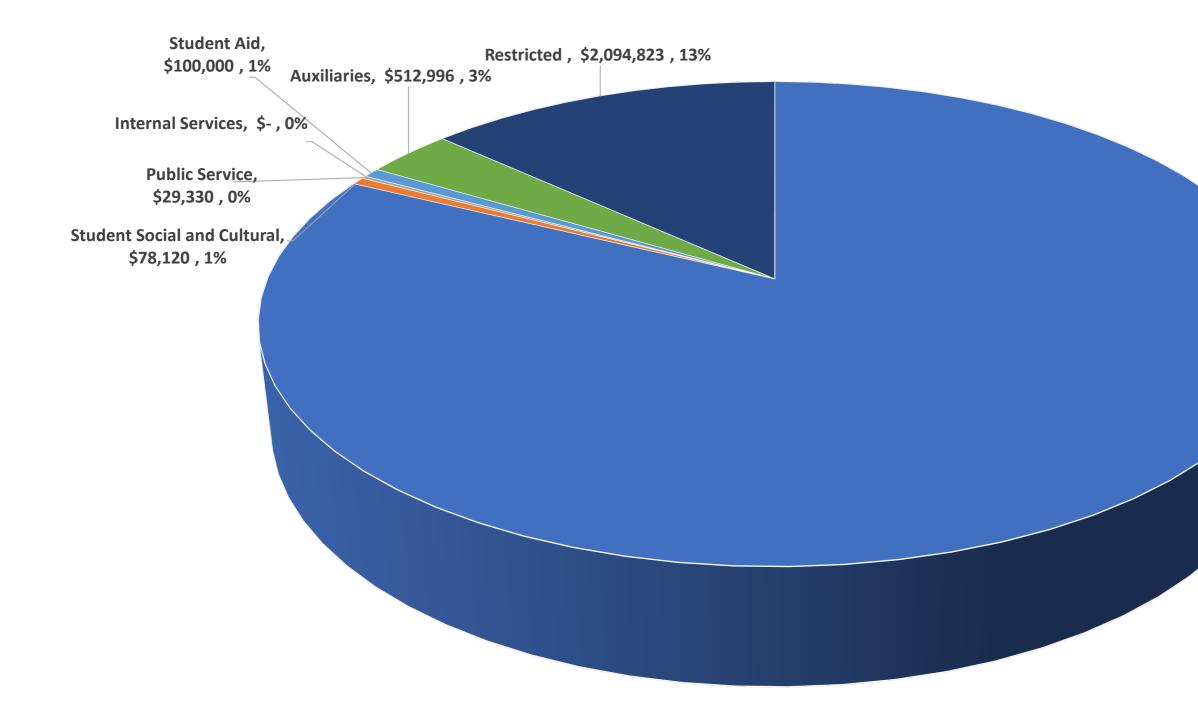


FY2022-2023 Instruction and General Expenditures



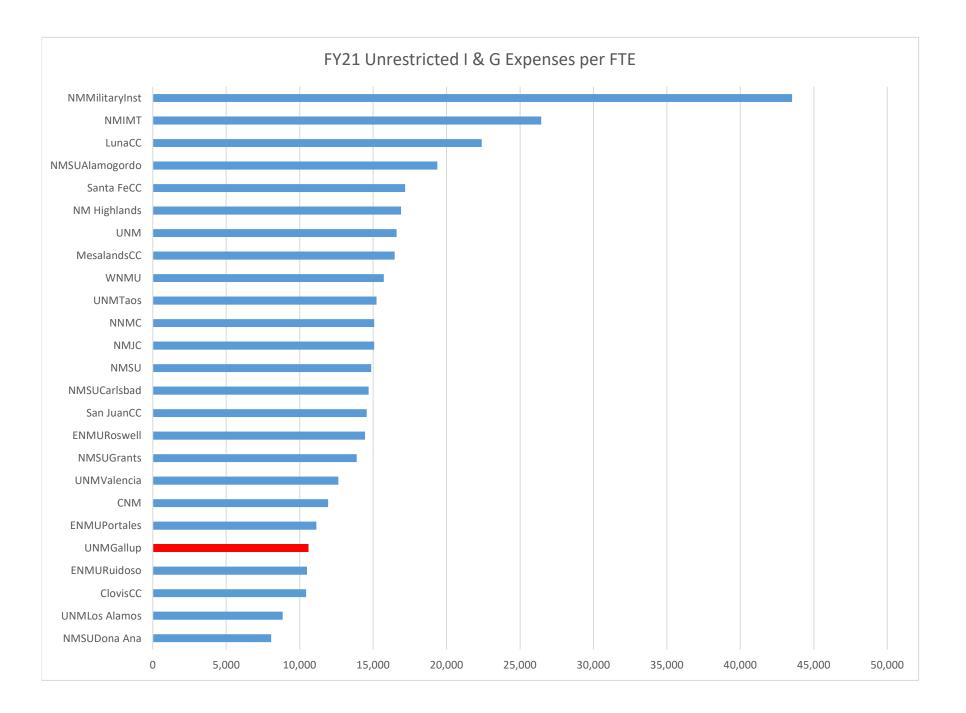
