### **OB: History of the Program**

The UNM-Gallup nursing program opened in March 2002. The nursing department offers three programs: the Certified Nurse Assistant, Associates of Science in Nursing, and the Bachelors of Science in Nursing. The current iteration of the Certified Nursing Assistant (CNA) certificate program is first offered at UNM-Gallup in 2012. However, the CNA program was being offered at the campus even before 2012. The CNA program has been the entry course and pre-requisite for the Associates of Nursing since implementing the New Mexico Nursing Education Consortium curriculum in Fall 2017.

Certified nurse assistants are healthcare professionals that assist nurses in hospitals, hospices, adult daycare centers, personal assisted living facilities, nursing homes, and other healthcare facilities. They work under the supervision of Registered Nurses (RNs). The job of CNAs varies depending on the facility in which they work. Their most common task is providing basic healthcare to patients, such as administering basic bedside care.

Approximately 80% of graduates remain in the area and work at local hospitals, clinics, and nursing homes. Several certified nurse assistant graduates have continued for their associates of nursing and/or bachelors of nursing degrees.

### **OC: Organizational structure**

The Certified Nursing Assistant (CNA) Certificate program is under the Division of Education, Health and Human Services Division, overseen by the division head. Under the division head, the Nursing Program Director oversees the Certified Nursing Assistant program's function and operation.

### **OD: External Program Accreditations**

The Certified Nursing Assistant certificate program is certified to operate under the New Mexico Department of Health (NMDOH). The NMDOH has reapproved the program to operate from January 5, 2021, until January 4, 2023. There are no specialized program accreditations for nursing assistant programs.

### **OE: Previous Program Review**

### **1A: Brief overview of the vision and mission of the Certified Nursing Assistant Program**

The UNMG Nursing Program's mission is to assist lifelong learners in developing critically competent and culturally sensitive nursing care for clients in rural health care settings.

UNMG program goals are to educate nursing graduates who will:

1. Use caring practices to promote health and healing.
2. Provide individualized care that recognizes diversity in a variety of settings.
3. Demonstrate therapeutic communication in the provision of patient, family, and community care and effective interprofessional communication.
4. Use critical thinking and the nursing process as a framework to provide safe and effective care for the patient, family, and community.
5. Integrate evidence and research findings into practice, including ethical and legal aspects of health care.
6. Display professional behavior, including a commitment to lifelong learning.

### **1B: Relationship of the program's vision and mission to the University of New Mexico's vision and mission**

1. Provide the opportunity for students to receive a quality education.
2. Provide the opportunity for students to prepare for employment and to become part of the workforce.
3. Provide the opportunity for students to develop their communication and professional skills.
4. Meet the needs of the community to improve quality of life.
5. Build a foundation for the student to become a lifelong learner.

### **1C: Certified Nursing Assistant Program Learning Goals**

The health sciences programs provide students with quality instruction in preparation for successful employment in an entry-level health field. The learning goals are interwoven in the topics covered in the course. The course syllabus includes course learning objectives indicating the skills and behaviors the student should know and be able to perform upon successful completion of the course. Our students will demonstrate:

1. Workplace skills that are specific to healthcare careers.
2. Knowledge of local, state, and federal guidelines that apply to the healthcare industry.
3. Basic knowledge of anatomy and physiology.
4. Knowledge of records documentation and basic medical terminology.
5. Team-building and communications skills; the basics of a good work ethic; and successful job-seeking strategies.
6. Where applicable, students will be prepared for the certification exam specific to the course.

The program learning goals are published in the UNM Gallup Catalog.

### **1E: Primary constituents and stakeholders**

The primary constituents are the nursing faculty, staff, and the nursing advisory committee members. The stakeholders are the nursing homes, hospitals, schools, and other healthcare-related entities within and around Gallup, NM. The faculty and staff meet with the nursing home administrators and hospitals' directors, and representatives from other healthcare-related entities every semester to share program information and events.

### **1F: Outreach or community activities**

The program participates in the yearly health fair organized by Rehoboth McKinley Christian Health Care Services (RMCHCS). Students offer blood sugar and blood pressure checks to willing health fair attendees. Students can apply the nursing skills (such as client communication, checking the blood sugar, and checking the blood pressure) they learned during the health fair.

### **2A: Description of the curriculum**

The program is designed in a short-term format featuring hands-on, skills-based learning techniques in the UNM Gallup Health Sciences Lab followed by clinical skills training in various healthcare settings specific to each course. A UNM Certificate is awarded upon successful completion of this program.

Nursing Assistant (CNA 101): 8 credit hours to include 96 clock hours lecture/skills lab and 32 clock hours clinical. Before entering the clinical setting in the final week of class, students must be certified in American Heart Association Basic Life Support of Healthcare Providers CPR and 1st Aid and have taken a TB test and other immunizations as specified in each course description. Employers in the healthcare setting will require a fingerprint background check and drug testing before hiring. Please see Appendix A for a copy of the CNA 101 course syllabus.

### **2B: Contributions of the program to other units/programs within UNM-Gallup**

Students may enroll in any of the allied health programs offered at UNM Gallup as they build on the basic skills required to provide care at various levels in the healthcare field. For example, CNA's are in demand in assisted living facilities and home healthcare. The basic skills learned in the CNA program are enhanced in the CNA classes and clinical settings and prepare students to sit for the nurse assisting certification exam and work in healthcare facilities under a Registered Nurse (RN). Prospective nursing students may be advised to take the CNA program before enrolling in area schools of nursing. Students who intend to transfer to a four-year college or university may enroll in the associate of science in Pre-Professional Health Sciences, which provides the academic core required for many healthcare careers.

### **2C: Modes of delivery**

The CNA 101 course is taught in-person. There are a lecture and skill lab component in the course. Students must complete clinical hours in a skilled nursing facility after completing the required lecture and skill lab hours.

### **3A: Program's assessment process and evaluation of student learning outcomes**

- What skills, knowledge, and values are expected of all students at the completion of the program (refer to learning goals outlined in Document 1)?
  - Students are expected to practice learned nursing skills safely and effectively in the workplace.
  - Must be able to understand the basic knowledge of anatomy and physiology.
  - Must understand the healthcare law and policies that apply in their workplace.
  - Understand the importance of proper documentation and proper use of basic medical terminology.
  - Possess good communication and collaboration skills.
  - Must be able to prepare for the nurse assisting certification exam.
- What are the student learning outcomes for the program?
  - Describe basic body structure and function as its relationship to health (including appropriate medical terminology and medical abbreviations)
  - Describe the physical, psychosocial, cultural, and spiritual needs of a resident/patient/client that can be met by the nursing assistant.
  - Describe techniques for the care of the cognitively impaired resident.
  - Perform basic nursing assistant skills in a safe and effective way (including care for the environment)
  - Identify common disorders and recognize abnormal changes in the body function that a nursing assistant would need to report to licensed practitioners.
  - Demonstrate effective oral and written communication skills.
- How have the student learning outcomes been changed or improved?
  - The student learning outcomes (SLO) have been slightly changed to align with the Program Learning Goals.
- How are the student learning outcomes clearly defined and measurable?
  - The SLOs describe the skills, knowledge, and values that students must possess after the course. The SLOs are worded using measurable action verbs that describe their level related to Bloom's Taxonomy.
- How are the student learning outcomes communicated to faculty and students?
  - The student learning outcomes are discussed with students in the course. Each student is given a copy of the course syllabus, which contains the student learning outcomes.
- What current direct and indirect assessment methods are used to evaluate the extent to which students are meeting the student learning outcomes?
  - The course uses a skill checklist to assess the student's level of skill mastery directly. Unit exams and quizzes are used as summative evaluation tools for evaluating students' knowledge of the nursing topics. A clinical skill checklist is used as a formative and summative tool for assessing students' skills and behavior during the clinical rotations.
- How have the program's assessment methods been changed or improved?
  - The program's assessment methods have not been changed or improved.

### **3B: The impact of the program's annual assessment activities**

- How have the results of the program's assessment activities been used to support quality teaching and learning?
  - The program's assessment results are reviewed at the end of each semester to determine if changes or additions are warranted to maintain teaching and learning quality. These assessment data are derived from final student grades, student clinical skill checklist, student survey feedback, and nurse assistant certification passing data.
- How have the results of the program's assessment activities been used for program improvement?
  - The program's assessment results are reviewed at least once every year to find trends and concepts that can be used to find the program's strengths and limitations. Information from the program assessment is regularly shared with faculty during faculty meetings.
- Overall, how is the program engaged in a coherent process of continuous curricular and program improvement?
  - Curricular and program improvements are brought up during faculty meetings, and information gathered from program assessment activities are shared with the faculty. Program improvements are discussed during faculty meetings.
- How does the program monitor the effects of changes?
  - Significant program changes are planned to be implemented at the start of a semester, and the effects of changes are monitored at least once during the semester.

#### **4A: Student recruitment and admissions**

Admission to the program is made at the beginning of each semester. The nursing program has a staff position designated explicitly for nursing advisement. Students work with the nursing advisor to ensure completion of pre-requisites and guide students through the registration process.

The nursing advisor does regular outreach to the Gallup-McKinley County School district to recruit interested students into the program. The nursing advisor also collaborates with other advisors from McKinley Academy to recruit students. Outreach is done at least once a semester. The nursing program also provides open sessions and invites interested community members to join the open sessions. The different program offerings are presented during these open sessions.

The Certified Nurse Assisting is a short-term certificate program. There is no data on persistence and retention because students complete the program in one semester. Very few students drop the course during the semester and most, if not all, successfully pass the course.

#### **4C: Program advisement for students**

The nursing program has a staff position designated explicitly for nursing advisement. Students work with the nursing advisor with admissions and the course registration process.

#### **4D: Student support services provided by the program**

The nurse assisting students have access to student support services such as advisement and student retention.

#### **4E: Student success and retention initiatives**

The nursing program advisor is also designated student success specialist to provide student support in the program. The student success specialist collaborates with the course instructor to identify low performing students. They assist by teaching time management and test-taking skills.

**4F: Graduate placement**

Students that complete the Certified Nurse Assisting course are eligible to take the state certification exam. The students who complete the state certification exam are qualified to work at various nursing homes and hospitals around Gallup. Other students continue to other programs such as the Associate of Science in Nursing or the Bachelor of Science in Nursing. There is no formal survey in place to track graduates once they leave the university to work.

**5A: Composition of faculty and their credentials.**

The program has one adjunct faculty teaching the CNA 101 course.

**6A: Program resource allocation and planning**

The faculty in the program has input in resource allocation and planning. The program assessment information is regularly shared with faculty. The program has a nursing advisory committee that meets twice a year. The faculty, nursing program director, and healthcare facility administrators compose the nursing advisory committee. Assessment information such as passing rates, student numbers, faculty and staff composition, program plans, healthcare facility plans, recruitment efforts are exchanged during the nursing advisory committee meetings. Recommendations made during the committee meetings are noted, and the faculty and the nursing program director will make the final decisions.

**6B: Program’s budget and support received from the institution**

The program gets the bulk of its operating budget from the university. The program also has nursing expansion funds available from the New Mexico Higher Education Program Development Fund in the Legislative General Appropriations Act. The Gallup Nursing Administration is the primary fund where the operating budget is taken out. Nursing full-time faculty and support staff salaries, office supplies, instructional materials, faculty and staff recruitment, and ancillary things are taken out from this budget. The nursing expansion fund is used for other costs and activities that the nursing program uses to support and maintain its quality teaching and learning. Additional nursing lab supplies, simulation lab supplies, nursing program accreditation fees, and professional development of nursing faculty are taken out from this fund.

**6C: Composition and responsibilities of the staff assigned to the program**

The nursing program has a dedicated nursing adviser staff that supports the program to achieve its goals.

**6D: Library resources that support the program’s academic initiatives**

The Zollinger library has a variety of services and resources that support the certified nurse assisting program. Print copies of our book are available in the Zollinger library. Students can also use the computer equipment in the lab when assigned a writing project. Conference rooms and group study rooms can also be used.

### **7A: Facilities the program uses**

The certified nurse assisting program have access to classrooms, nursing skills lab, computer lab, adjunct faculty offices, conference room, simulation lab, and manikin in the Health Careers II building. All nursing classrooms have been fitted with computer projectors, microphones, and speaker systems for didactic courses for enhanced learning activities. Students can use the nursing manikins to learn and practice various basic nursing skills. The nursing lab is laid out and fitted with nursing care equipment that students will encounter in their work environments. The students have access to the computer lab in the Health Careers building.

### **7B: Computing facilities used by the program**

The program has access to 33 desktop PCs in the Health Careers II computer lab. The UNM-Gallup IT department maintains the computers in the lab.

**8A: Program comparisons**

The UNM-G Nurse Assisting Certificate Program is of sufficient quality and comparable to programs at peer institutions. The program descriptions, course descriptions, and minimum credit hours required for completion are very similar to its peer institutions such as Navajo Technical University, San Juan Community College, and Central New Mexico Community College. Navajo Technical University’s offering is different in terms of minimum credit hours required to complete the certificate of 32 to 33 credit hours. The UNM-G Nurse Assisting Certificate Program has similar student characteristics with peer institutions such as Navajo Technical University and San Juan Community College. The New Mexico Department also approves all certificate program offerings from peer institutions of Health.

The UNM-G Nursing Assisting Certificate Program is of sufficient quality and comparable to programs regionally and nationally. The program descriptions and course descriptions are very similar to Gateway Community College in Phoenix, Arizona. Their minimum credit hours required for completion are not too far from UNM-Gallup’s offering.

- Hiring a nurse educator is a challenge due to the continued shortage and increased demand for nurses.
- Adding CNA 101 section is a challenge due to shortages for nurse educators.

The nursing faculty will continue to monitor healthcare trends to determine necessary changes or corrections.
